



CRITERIA FOR GRADUATION

1. Pharmacist licensure from the NJ Board of Pharmacy by September 1st
2. Earning an "Achieved for the Residency" for 9 goals of the required 32 ASHP goals
3. Earning an "Achieved for the Residency" for 80% of the remaining 23 goals
4. Completion of 1 IRB approved residency project and written manuscript in publishable form and 1 medication use evaluation
5. Create Hospital's Policies and Procedure
6. Provide, at a minimum:
 - 1 patient case presentation
 - 10 topic discussions & formulary monograph
 - 2 journal clubs & 2 formal DI questions
 - 1 clinical competency education lecture
 - 1 pharmacy inservice & 5 clinical huddles
 - 1 nursing or medical provider education
 - Revise or create 1 hospital policy
 - Submit a written manuscript in publishable form for the residency research project
7. Participate in Pharmacy and Therapeutics meetings and prepare minutes for the meetings
8. Attend/observe the following committee meetings as a guest at least once
 - Antibiotic Stewardship Committee
 - Medication Safety Meeting
 - Medication Management
 - RWJBH Clinical Council

9. Maintain active involvement in ASHP and NJSHP
 - Poster at ASHP Midyear
