# LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP)

LIHEAP or HEA is a federally funded program that helps low-moderate income households pay for heating costs (all fuel types). Even if your heat is included in your rent, you may qualify. LIHEAP grants are also available for medically necessary cooling costs. Applications are accepted from October 1 through June 30 each year. (See chart on next page for income limits).

#### UNIVERSAL SERVICE FUND (USF)

USF is a program that provides monthly credits on residential electric and natural gas bills as well as forgiveness of overdue balances through the USF-Fresh Start program. Monthly USF credit amounts are based on energy costs in relation to income. USF is administered by the Department of Community Affairs. Fresh Start is administered by the gas and electric companies. USF is made possible by the Board of Public Utilities.
