PROGRAM BACKGROUND

The RWJBarnabas Health (RWJBH) Institute for Prevention and Recovery (IFPR) Peer Recovery Program (PRP) provides in-person and virtual recovery support services for individuals with substance use disorder. PRP employs Recovery Specialists who are in recovery from substance use disorder and provide consultation and peer recovery support as well as clinically trained Patient Navigators who link individuals to appropriate levels of care. 1

PRP, formerly known as the Opioid Overdose Recovery Program (OORP), serves patients 24 hours a day, 7 days a week, in hospitals throughout Essex, Hudson, Mercer, Middlesex, Monmouth, Ocean, Somerset, and Union counties. In addition to serving emergency department patients who received naloxone to reverse an opioid overdose, PRP also serves patients with substance use disorder in emergency departments of all participating hospitals, inpatient units of RWJBH hospitals, and outpatient settings. 
REPORT OVERVIEW

In 2024, Recovery Specialists received referrals during 19,526 patient encounters. During 5,435 follow-up calls conducted one year post-consultation, 131 patients reported being in recovery, representing 2% of eligible patients and 66% of patients who were successfully contacted.

The 2024 Annual Report presents information on referrals, the population served, and program outcomes, as well as **program updates (see pages 5 and 6).** The Appendix contains data stratified by location. The information included in this report is preliminary and subject to change.

REFERRAL SUMMARY

Recovery Specialists received **19,526 referrals** in 2024. There were 18,478 referrals in 2023, 18,130 referrals in 2022, 16,244 referrals in 2021, 18,475 referrals in 2020, 18,585 referrals in 2019, 9,060 referrals in 2018, 1,898 referrals in 2017, and 720 referrals in 2016. PROGRAM UPDATES

On October 7, 2024, Alexis LaPietra, DO, FACEP, Medical Director, IFPR, and System Director of Addiction Medicine, Emergency and Hospitalist Medicine service line, conducted a training on medications for opioid use disorder (MOUD) at Trinitas Regional Medical Center for PRP leadership, emergency department (ED) physicians, nurses, and other clinical staff to better understand how MOUD can be utilized to improve patient outcomes. This presentation has evolved into a monthly multidisciplinary team meeting to share ideas and implement action plans for patients with opioid use disorder.

On October 8, 2024, Amanda Kube, PRP Manager, and Rich Hoffman, PRP Supervisor, presented an overview of PRP to the new medical residents at Monmouth Medical Center, informing them about the roles of Recovery Specialists and Patient Navigators, how to submit referrals and collaborate effectively with PRP, and ways to support patients with substance use disorder. On October 10, 2024, Amanda and Rich presented to the patient sitters at Monmouth Medical Center Southern Campus, providing an overview of PRP and explaining how sitters can support patients and families impacted by substance use disorder.

On October 18, 2024, **15 IFPR staff attended the Center for Great Expectations Hope Lives Here Gala** in Somerset. The night was filled with compassion, inspiration, and the collective commitment to rebuilding lives.

On October 22, 2024, Angela Cicchino, PRP Manager, and Kathryn Maher, PRP Supervisor, presented "Holistic Care for Pregnant Women with Substance Use Disorder" (pictured right) at the New Jersey Association of Mental Health and Addiction Agencies (NJAMHAA) Fall Conference in Princeton.



PROGRAM UPDATES

On November 13, 2024, Connie Greene, Senior Vice President, IFPR, was honored for her leadership and pioneering work in behavioral health (pictured right) by the Mental Health Association in New Jersey (MHANJ) at its 24th Annual Evening of Excellence and 80th Anniversary Celebration in Florham Park.



On November 15, 2024, Patrick Conley, PRP Manager, and Amanda Kube, PRP Manager, attended the Ocean County Health Department's workshop, "Culture and Ethics in Crisis Response: Prioritizing Self-Care and Resilience," presented by Alexandra Lopez, Associate Professor, Rutgers University, in Toms River.

On December 4, 2024, **IFPR's PRP leadership team convened for their quarterly strategic planning meeting** at Cooperman Barnabas Medical Center and focused on evaluating the current PRP workflow. The discussion centered around highlighting PRP's successes, identifying significant areas of impact, and recognizing challenges to optimal service delivery. The team explored several opportunities for improvement, aiming to enhance PRP's effectiveness and patient care.

On December 6, 2024, Amanda Kube, PRP Manager, was interviewed by the New Jersey Prevention Network about the importance of utilizing recovery-oriented language (ROL). ROL focuses on eliminating stigmatizing language to describe people who may be experiencing substance use or mental health challenges. It also emphasizes strength, hope, and the possibility of growth rather than defining people by their struggles or diagnoses.







REFERRAL SUMMARY


Fewer than one in ten referred patients received at least one dose of naloxone prior to consultation. More than three-quarters of referrals were placed in the emergency department; the remainder were placed in inpatient units and outpatient settings. Referrals by day of the week and time of day are shown below.

Throughout this report, "Unknown" consists of responses of "Do not know" or "Refused" and missing data. Additional data is available in the Appendix.












POPULATION SERVED


Of the 19,526 referred patients, approximately two-thirds were male. Most patients were between the ages of 26-44 (41.1%) and 45-64 (40.8%). Approximately four in ten (43.1%) patients were white, 31.2% were Black, and 16.8% were Hispanic/Latino. The majority of patients were covered by Medicaid (44.5%) or were uninsured (17.6%), 14.6% were homeless, and 37.0% did not have access to transportation.












PROGRAM **OUTCOMES**

To measure success, the Institute for Prevention and Recovery utilizes the Substance Abuse and Mental Health Services Administration's (SAMHSA's) working definition of recovery, which emphasizes the process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential.² Four major dimensions—health, home, purpose, and community—support recovery. PRP assists in the process of recovery by providing recovery support services and clinical referrals.

In 2024, 54 patients were not available for consultation (e.g., left against medical advice, were unresponsive, were deceased). 95.8% of patients available for consultation accepted consultation by a Recovery Specialist. 91.0% of patients who accepted consultation also accepted some form of support services.








PROGRAM OUTCOMES (CONTINUED)

In 2024, patients accepted 1,587 referrals to levels of care offered by Patient Navigators, including 872 referrals to withdrawal management and 109 referrals for medications for opioid use disorder. Accepted and offered referrals are included in the Appendix.




Recovery Specialists follow up with patients for a minimum of eight weeks postconsultation. In 2024, PRP staff conducted 160,194 instances of follow-up, including 15,288 face-to-face contacts. Patient Navigators were responsible for approximately one-tenth of all instances of follow-up.






PROGRAM OUTCOMES (CONTINUED)

PRP staff follow up with patients 3, 6, 9, and 12 months post-consultation to assess long-term recovery. In 2024, PRP staff attempted 25,837 of these followup calls, and 1,225 patients were successfully contacted. Of patients contacted one year post-consultation, 131 reported currently being in recovery, representing 2.4% of eligible patients and 66.1% of patients who were successfully contacted.






CLINICAL SUPPORT SUPERVISION


IFPR supports and encourages workforce development for individuals in recovery. To ensure that all PRP Recovery Specialists are National Certified Peer Recovery Support Specialists (NCPRSS) and the best that they can be, IFPR offers support and guidance through Clinical Support Supervision (CSS). Nine Supervisors offer a minimum of one individual and one group supervision session per month to each Recovery Specialist. Supervisors complete the Certified Clinical Support Training offered by the New Jersey Prevention Network (NJPN).

Though separate, CSS works in conjunction with administrative supervision offered by PRP Managers. CSS focuses on the Code of Ethics (NAADAC) and Core Competencies (SAMHSA); professional goals; self-care practices and compassion fatigue awareness; enhancing peer support work and strengthening skills; boundaries; identifying role difference, role drift, and scope of peer work; and teamwork skills.

In 2024, Clinical Support Supervisors held 936 individual sessions and 70 group sessions averaging six attendees per session.





In 2024, Clinical Support Supervisors and Recovery Specialists discussed ethical conduct in approximately three-quarters of CSS sessions and the Recovery Specialist-patient relationship in more than three-quarters of CSS sessions. The most frequently discussed Core Competencies were provides support, shares lived experience of recovery, supports collaboration and teamwork, and engages peers in collaborative and caring relationships.




NALOXONE DISTRIBUTION

PRP partners with RWJBarnabas Health's Corporate Pharmacy Division and the Rutgers Opioid Overdose Prevention Network (OOPN) to distribute naloxone. In 2024, Recovery Specialists distributed 1,304 naloxone kits to patients. The majority of these kits were dispensed to patients in Hudson County (27.8%), Essex County (20.2%), and Union County (19.1%). Jersey City Medical Center distributed the most kits (n=363).







ED MOUD QUALITY METRIC

In 2023 Quarter 2, RWJBH facilities adopted an incentivized ED quality metric attributed to buprenorphine induction for naloxone-reversed patients in the ED. Patients are excluded from the metric if they have been admitted to the hospital after being treated in the ED, if they are unavailable for services (e.g., PESS), or they were inappropriately referred to PRP (e.g., received naloxone as a precaution). In 2024, 64.1% of patients were administered or prescribed buprenorphine, which surpassed the 2024 goal of 50%. In addition, 84.7% of patients were given a naloxone kit, which surpassed the 2024 goal of 75%.





ED MOUD QUALITY METRIC (CONTINUED)

Since the inception of the ED MOUD quality metric, the proportion of patients administered or prescribed buprenorphine post-naloxone reversal has continued to trend upwards.



Buprenorphine administrations and prescriptions have increased for nonnaloxone-reversed patients as well as patients included in the ED MOUD quality metric.


