CRITERIA FOR GRADUATION

1. Pharmacist licensure from the NJ Board of Pharmacy by September 1st
2. Earning an "Achieved for the Residency" for 9 goals of the required 32 ASHP goals
3. Earning an "Achieved for the Residency" for 80% of the remaining 23 goals
4. Completion of 1 IRB approved residency project and written manuscript in publishable form
5. Completion of a medication use evaluation
6. Create or revise 1 hospital policy, procedure, or protocol
7. Provide, at a minimum:
 - 10 topic discussions
 - 1 patient case presentation
 - 1 formulary monograph
 - 2 journal club presentations
 - 2 formal drug information questions
 - 1 clinical competency education lecture
 - 1 pharmacy inservice
 - 5 clinical huddles for pharmacy department
 - 1 nursing or medical provider education
8. Participate in and prepare minutes for Pharmacy and Therapeutics committee meetings
9. Attend/observe the following committee meetings as a guest at least once:
 - Medication Safety Meeting
 - Medication Management Meeting
 - RWJBH Clinical Council Meeting
 - RWJBH Directors' Council Meeting
10. Maintain active involvement in ASHP and NJSHP:
 - Poster at ASHP Midyear
 - Poster at NJSHP Annual Meeting
 - Platform at Eastern States Conference
