## PATIENT RIGHTS

If you have questions or concerns regarding your hospitalization, please speak with your nurse. Each nursing unit also has a nurse manager who is available to assist you. For additional assistance, you can contact the Patient Advocate Office between 9 a.m. and 5 p.m. weekdays at 732-499-6136 or 732-499-6440. Evenings or on weekends, ask the operator to connect you to the clinical administrative coordinator.

Every New Jersey hospital patient shall have the following rights, none of which shall be abridged by the hospital or any of its staff. The hospital administrator shall be responsible for developing and implementing policies to protect patient rights, and to respond to questions and grievances pertaining to patient rights. These rights shall include at least the following:

- To receive the care and health services that the hospital is required by law to provide.
- To treatment and medical services without discrimination based on age, religion, national origin, sex, sexual preferences, handicap, diagnosis, ability to pay or source of payment.
- To exercise all your constitutional, civil and legal rights.
- To receive an understandable explanation from your physician of your complete medical condition, recommended treatment, expected results, risks involved and reasonable medical

alternatives. If your physician believes that some of this information would be detrimental to your health or beyond your ability to understand, the explanation must be given to your next of kin or guardian.

- To receive appropriate assessment and treatment of pain.
- To choose your own private professional nurse and contract directly for this care during hospitalization.
- To give informed, written consent prior to the start of specified, nonemergency medical procedures or treatments. Your physician should explain to you—in words you understand—specific details about the recommended procedure or treatment, any risks involved, time required for recovery, and any reasonable medical alternatives.
- To refuse medication and treatment after possible consequences of this decision have been explained clearly to you, unless the situation is life-threatening or the procedure is required by law.
- To freedom from restraints, unless they are authorized by a physician for a limited period of time to protect the safety of you or others.
- To be included in experimental research only if you give informed, written consent. You have the right to refuse to participate.
- To be informed of the names and functions of all healthcare professionals providing you with personal care.
- To receive, as soon as possible, the services of a translator or interpreter if you need one to help you communicate with the hospital's healthcare providers.
- To be informed of the names and functions of any outside healthcare and educational institutions involved in your treatment. You may refuse to allow their participation.
- To receive, upon request, the hospital's written policies and procedures regarding life-saving methods, and the use or withdrawal of life support mechanisms.
- To be advised in writing of the hospital's rules regarding the conduct of patients and visitors.

## Information

- To receive a summary of your patient rights that includes the name and phone number of the hospital staff member to whom you can ask questions or complain about any possible violation of your rights.
- To have prompt access to the information in your medical record. If your physician feels that this access is detrimental to your health, your next of kin or guardian has a right to see your record.
- To obtain a copy of your medical record, at a reasonable fee, within 30 days after a written request to the hospital.

- To receive a copy of the hospital payment rates. If you request an itemized bill, the hospital must provide one and explain any questions you may have. You have a right to appeal any charges.
- To be informed by the hospital if part or your entire bill will not be covered by insurance. The hospital is required to help you obtain any public assistance and private healthcare benefits to which you may be entitled.
- To receive information and assistance from your attending physician and other healthcare providers if you need to arrange for continuing healthcare after your discharge from the hospital.
- To receive sufficient time before discharge to arrange for continuing healthcare needs.
- To be informed by the hospital about any appeal process to which you are entitled by law if you disagree with the hospital's discharge plans.
- To be transferred to another facility only when you or your family has made the request or in instances where the transferring hospital is unable to provide you with the care you need.
- To receive an advance explanation from a physician of the reasons for your transfer and possible alternatives.

## Your Privacy

- To be treated with courtesy, consideration, and respect for your dignity and individuality.
- To have access to storage space in your room for private use. The hospital also must have a system to safeguard your personal property.
- To freedom from physical and mental abuse.
- To have physical privacy during medical treatment and personal hygiene functions, unless you need assistance.
- To confidential treatment of information about you. Information in your records will not be released to anyone outside the hospital without your approval, unless it is required by law.

## Concerns

- To present questions, complaints or grievances to a designated hospital staff member, and to receive a response in a reasonable period of time. The hospital must provide you with the address and telephone number of the New Jersey Department of Health that handles questions and complaints. ## *RWJ HEALTH CONNECT*

Your Guide to Understanding Health Information Organizations (HIO)

**What is an HIO?** A Health Information Organization (HIO) is a group of healthcare facilities established to help patients and their authorized healthcare providers, who are treating the same patient, share—or exchange—relevant healthcare information.

**What are the benefits of HIO to patients?** Historically, a major obstacle in care delivery has been untimely and limited access to patient medical information. Because most patients see multiple providers, their medical information has to be shared across different systems based on different technologies. These technical differences create barriers to sharing and using information in a timely manner, resulting in delays, duplicated efforts and testing, potential errors, etc.

**How is my medical information secured?** Protecting patient privacy is a top priority for RWJ Health Connect, and access to patient data is strictly regulated. RWJ Health Connect has internal requirements above and beyond those set by law.

**Can I choose not to participate?** In the event that you are not comfortable with participating in RWJ Health Connect, you can choose to opt out. You have several options for opting out of the RWJ Health Connect Health Information Exchange. Please select one below:

## PATIENT RESPONSIBILITIES

RWJ Rahway strives to ensure that all patients are provided with comprehensive, quality and cost-effective healthcare services. In order to do this most effectively and to maximize your involvement and participation in the healthcare process, we ask that you adhere to the patient responsibilities that follow.

It is your responsibility as a patient to:

- Provide accurate information about your past and present medical history, including all medications that you are taking.
- Know the physician in charge of your care and the people on your healthcare team.
- Actively participate in your plan of care decisions and include your family/significant other to help provide for your discharge needs.
- Ask questions about your medications, diagnostic test results and anything you do not understand.
- Be considerate of other patients' needs for rest, quiet and privacy.

- Follow hospital rules and regulations affecting patient care and conduct.
- Provide complete and accurate information necessary for processing your hospital bill.
- Be responsible for items on your bill not covered by insurance.
- Respect hospital property as well as the private property of other patients and hospital personnel. Hospital property should not be removed from the hospital premises.
- Inform physicians, nurses and other medical personnel if you have any concerns regarding your care.
- In our educational resources, RWJ Rahway strives to be culturally, religiously and spiritually sensitive to all people who access our healthcare and education. If we can be more sensitive in our materials, please forward your comments to the Patient Advocate Office, 732-499-6136.

## *COMMUNICATION NEEDS*

RWJ Rahway strives to effectively communicate with all patients. Patients and family members who are deaf, hard of hearing or sight impaired are encouraged to ask for special assistance.

Interpreter services for deaf and limited English proficiency will be provided as needed. We have a special phone for translations of most languages. Your nurse can make the necessary arrangements.

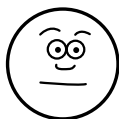

## PAIN MANAGEMENT

Pain Management is an important part of your treatment. Please do not hesitate to tell your nurse or doctor:

- When you have pain.
- If your pain is not relieved.
- If you have other symptoms along with your pain, or as a result of your pain treatment plan.
- If you have concerns about taking medications.
- If you have questions about your pain treatment plan.

## MESSAGE FROM MEDICARE: YOUR RIGHTS AS A HOSPITAL PATIENT

- You have the right to receive necessary hospital services covered by Medicare, or covered by your Medicare Health Plan (“your Plan”) if you are a Plan enrollee.
- You have the right to know about any decisions that the hospital, your doctor, your Plan, or anyone else makes about your hospital stay and who will pay for it.
- Your doctor, your Plan, or the hospital should arrange for services you will need after you leave the hospital. Medicare or your Plan may cover some care in your home (home healthcare) and other kinds of care, if ordered by your doctor or by your Plan. You have a right to know about these services, who will pay for them, and where you can get them. If you have any questions, talk to your doctor or Plan, or talk to other hospital personnel.

## *DISCHARGE & MEDICAL APPEAL RIGHTS*

Your doctor and/or plan may determine that you can safely be discharged from the hospital. If you have Medicare, you may be advised of this anticipated discharge up to two days beforehand. When your doctor discharges you, you have the right to appeal this decision.

If you stay in the hospital after your planned date of discharge, it is likely that your charges for additional days in the hospital will not be covered by Medicare or your Plan, and you may be financially responsible.

### **Discharge**

As soon as you are aware that you will be discharged, please make arrangements for your return home as quickly as possible.

\*Discharge needs to be before 12 p.m.

### **Your Right to an Appeal without Financial Risk**

If you have Medicare and you are advised of your planned date of discharge, or if you think you are being asked to leave the hospital too soon, you have the right to appeal to the Quality Improvement Organization (QIO). The QIO is authorized by Medicare to provide a second opinion about your readiness to leave. The name of the QIO in New Jersey is Livanta BFCC-QIO. The number is 866-815-5440, TTY number is 866-868-2289. You can leave a voicemail anytime, all calls returned. Fax number for appeals is 855-236-2423. You may call Medicare, toll free, 24 hours a day, for more information about asking your QIO for a second opinion. That number is 1-800-MEDICARE (1-800-633-4227) or TTY/TTD: 877-486-2048.

If the QIO agrees with the hospital discharge plan, then it will tell you when your financial liability will begin.

### **Other Appeal Rights**

If you miss the deadline for filing an immediate appeal while still in the hospital, you still may appeal and request a review by the QIO 30 days after you have been discharged.

### **CASE MANAGEMENT**

In acute care hospitals, hospital stays are generally short, usually a few days. That is why discharge planning needs to start on the day of your admission. We do this because the goal is to smoothly transition you to the most appropriate place to heal, whether that's at home with supportive services or another type of facility.

The Case Management Department at Robert Wood Johnson University Hospital Rahway is made up of case coordinators, who are registered nurses, and medical directors. During the inpatient hospital stay, you will be evaluated to see if you may need alternative levels of care or healthcare services in the community, such as home health services.

Our case coordinator will discuss with you, your family, and physicians your status and needs upon discharge. Family meetings also can be arranged.

Case coordinators also provide clinical information to health insurance companies for approval of hospital stay days and authorization of ongoing health needs.

### **SOCIAL SERVICES**

#### **Helping Patients and Families Cope**

The Social Services Department at Robert Wood Johnson University Hospital Rahway is available to help plan care and services upon discharge for patients and families. There is a social worker designated to each unit that serves as a part of the healthcare team. The social worker links the patient/family to services that help enhance the patient's function at home and in the community. Referrals can be made for public assistance, legal issues, entitlement programs and other resources.

## ***BILLING***

RWJ Rahway cannot assure that all physicians or consultants participate in all insurance plans. **Your physicians' bills will be separate** from the hospital bill. Please contact your insurance company to find out if these physicians are covered by your plan. If you have questions regarding a physician bill, please contact the physician's billing office.

### **Physician Fees**

Most physicians' fees are payable directly to the physicians. In the instance where Medicare covers a patient for interpretation of electrocardiograms, tests are billed to Part B of Medicare with the balance payable by the patient to the hospital.

### **Radiology Billing**

The interpretation of radiology films is provided by a private group of physicians who specialize in radiology. Patients will receive a bill separate from their hospital bill for this service. The radiology group accepts payment from Medicare and private payers, but the patient is responsible for the balance of an allowable charge not covered by an insurance carrier.

### **Surgical Assistants Billing**

Surgical assistants are required by the state of New Jersey for all major surgeries. Accordingly, you will receive a separate bill for services rendered by each of the assistants, who are qualified surgeons.

### Anesthesia Billing

Patients will receive a separate bill for anesthesia services. A private anesthesia group whose billing is separate from either the hospital or the surgeon provides these services. The Anesthesia Office will automatically file claims for patients with Medicare and Blue Shield coverage. Medicare will send the payment directly to the anesthesia group. The patient is responsible for any balance not paid by insurance.

### Emergency Medical Associates Billing

Patients who enter the hospital through the Emergency Department also will receive a separate bill for the physicians' services. Emergency Medical Associates, a group of physicians whose specialty is Emergency Medicine Associates (EMA), provide these services for RWJ Rahway. This bill will be separate from the hospital bill or your private doctor's bill. The billing office will automatically file claims for Medicare and private payers providing the patient gives the accurate information upon admission. Patients are responsible for the balance of an allowable charge not covered by an insurance carrier. Questions regarding the emergency medical associates' bills should be referred to Bravo Reimbursement Specialists, billing company, for EMA, 800-345-0064, Monday through Friday, 9 a.m. to 5 p.m.

### Pathology Billing Procedure

Diagnostic/Pathology services are provided by a private group of physicians who specialize in pathology. Patients will receive a bill separate from their hospital bill for this service. The pathology group accepts payment from Medicare and private payers, but the patient is responsible for the balance of an allowable charge not covered by an insurance carrier.

### Charity Care

RWJ Rahway will provide services without charge or at a reduced charge to New Jersey residents who: 1) have no health coverage or have coverage that pays for part of the bill only; 2) are ineligible for any private or government-sponsored coverage; and 3) meet the income and asset eligibility criteria. Contact the Charity Care Office, 732-499-6169, if you believe you might be eligible.

## Financial Assistance Program

Robert Wood Johnson University Hospital Rahway's Financial Assistance Policy/Program (FAP) exists to provide eligible patients partially or fully discounted emergency or other medically necessary healthcare services provided by RWJUHR. Patients seeking financial assistance must apply for the program, which is summarized below:

**Eligible Services** – Emergency or other medically necessary healthcare services provided by RWJ Rahway and billed by RWJ Rahway.

The FAP only applies to services billed by RWJ Rahway. Other services that are separately billed by other providers, such as physicians or laboratories, are not covered under the FAP.

**Eligible Patients** – Patients receiving eligible services who submit a complete Financial Assistance Application (including related documentation/information), and who are determined eligible for financial assistance by RWJ Rahway.

**How to Apply** – FAP and the related Application may be obtained/completed/submitted as follows:

Paper copies of the FAP, Application and PLS are available, upon request, by mail, without charge, and are provided in various areas throughout the hospital facilities including Admission Department, Emergency Department, and financial counseling offices listed below:

The main Registration Department or the Emergency Department Registration desk;

The Credit and Collection office located off of the hospital's main lobby; Monday through Friday, 9 a.m. to 4:30 p.m.;

Inpatients may request to be screened for financial assistance at that time and begin the application process by calling 732-499-6169;

Calling the Patient Accounts Department at 732-381-4200, ext. 2017—Monday through Friday, 9 a.m. to 4:30 p.m.; and

Mail or deliver in person the completed applications (with all documentation/information specified in the application instructions) to: RWJ Rahway's Credit and Collection Office, 865 Stone St., Rahway, NJ 07065. Email your completed application (with all documentation/information specified in the application instructions) to: [charity.care@rwjuhr.com](mailto:charity.care@rwjuhr.com).

**Determination of Financial Assistance Eligibility** – Generally, eligible persons are eligible for financial assistance, using a sliding scale, when their family income is at or below 500 percent of the Federal Government's Federal Poverty Guidelines (FPG). Eligibility for financial assistance means that eligible persons will have their care covered fully or partially, and they will not be billed more than "amounts generally billed" (AGB) to insured persons (AGB, as defined in IRS Section 501(r) by the Internal Revenue Service). Financial assistance levels, based solely on family income and FPG, are:

Less than or equal to 200%	00%
Greater than 200% but less than 225%	20%
Greater than 225% but less than 250%	40%
Greater than 250% but less than 275%	60%
Greater than 275% but less than 300%	80%
Greater than 300% but less than 500% lesser of: AGB% Medicare rate	

**Note:** Other criteria beyond FPG also are considered (i.e., availability of cash or other assets that may be converted to cash, and excess monthly net income relative to monthly household expenditures), which may result in exceptions to the preceding. If no family income is reported, information will be required as to how daily needs are met. RWJ Rahway's Credit and Collection Department reviews submitted applications that are complete, and determines financial assistance eligibility in accordance with the RWJ Rahway's FAP. Incomplete applications are not considered, but applicants are notified and given an opportunity to furnish the missing documentation/information.

RWJ Rahway also translates its FAP, FAP application form and the plain language summary of its FAP in other languages wherein the primary language of the residents of the community served by RWJ Rahway represents 5 percent or 1,000, whichever is less, of the population of individuals likely to be affected or encountered by RWJ Rahway. Translated versions are available, upon request, in person, at the address below; and on RWJUHR's website.

### Medical Insurance

If you are covered by hospitalization insurance, please be sure you present your insurance ID card with the proper policy number and current billing address. Also it may be necessary for you to get an authorization or pre-certification for your service. Please submit this information to the registrar during your registration process. You will be expected to sign all assignment of benefits.

### No Fault

If your admission is due to an automobile accident (either moving or stationary), your normal hospital charges are payable by your automobile insurance carrier.

### Deductibles and Co-Payments

If your insurance plan has a deductible or coinsurance, this should be paid prior to your discharge.

## Medicaid

If you are a Medicaid patient, you should present your Health Services Program identification card and assigned person number when you are admitted. The person number, also which validates coverage for each member of the family, appears on your monthly check stub. In addition, you must present your managed Medicaid (HMO) identification card when registering for services.

## Medicare

If you are a Medicare patient, you must present your health insurance identification card or managed Medicare card when you are admitted to show whether you are enrolled in Part A (Hospital) and/or Part B (Medical). If you also subscribe to supplemental insurance (coinsurance), proper identification should be submitted at admission. You must submit proper insurance forms. If you do not subscribe to any supplemental insurance, you must pay the Part A deductible prior to discharge. Your copy of your Medicare Handbook will aid you in filling out Form SSA-1490, the reimbursement form for physicians' payments.

## Hospital Billing Information

Because computers perform our billing within five days of discharge, there are occasions when all the charges are not received in time to be itemized. Such charges will be billed at a later date. If you have any questions regarding your hospital bill only and insurance coverage, please call the Patient Billing Department. Insurance policies vary widely, but every effort will be made to satisfy your particular inquiry. Please dial 732-499-6007 or 844-579-2602 between 8 a.m. and 4:30 p.m. Monday through Friday.

## Uninsured Patients

If you do not subscribe to any hospitalization insurance, you will be required to provide a deposit in an amount determined by the director of Patient Access upon admission. You also may inquire about obtaining assistance through NJ Charity Care program or other state-funded programs. (See Charity Care Information in this guide.) You also can inquire about our RWJ Rahway Financial Assistance Program.

## *FOR SAFETY'S SAKE*

Do not bring medications to the hospital; however, please bring a list of all the medications that you are currently taking. All necessary medications will be ordered by the physician and provided by the hospital.

Personal electrical appliances and electronic equipment are not permitted in the hospital.

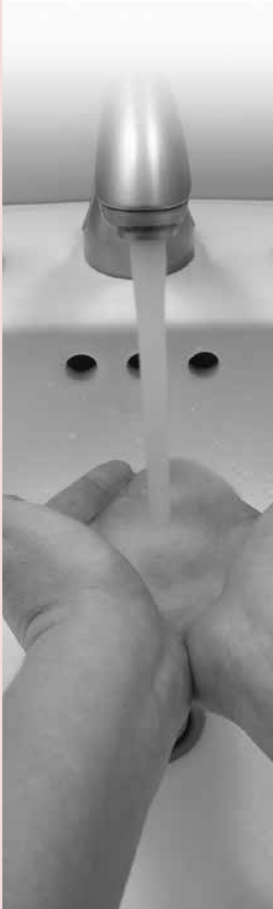
Cellphones may be used in the hospital. Please use your discretion in patient care areas.

Be aware that hospital beds are narrower and higher than those used at home. Never leave your bed without assistance or without your physician's permission. Do not adjust side rails or attempt to climb around them. Call a staff member to help you out of bed or to move the side rails.

## Safety

### Wash Your Hands:

- Before you eat
- After you use the bathroom
- After touching body fluids; for example, coughing, sneezing, etc.
- When your hands are visibly dirty



Always use the call bell when assistance is required. If any equipment or appliance seems to be operating improperly, notify the nurse. If any heat treatment seems too warm, advise the nurse immediately.

When oxygen is in use, do not light matches or other devices with an open flame.

### Handwashing

Handwashing/hand cleaning is the single most important way to prevent the spread of illnesses in a healthcare facility.

When should you wash your hands?

- Before you eat.
- After you use the bathroom.
- After touching body fluids, for example, coughing, sneezing, etc.
- When your hands are visibly dirty.

Remember, it is all right to ask your caregivers if they have washed their hands!

## *DENTURES, EYEGASSES & OTHER PERSONAL BELONGINGS*

If you wear dentures, hearing aids or eyeglasses, you are responsible for their safekeeping during your hospital stay. We urge you to keep them in appropriate containers in your cabinet drawer when they are not in use. The hospital provides a plastic container for these devices. If you do not have your own, ask your nurse to give you one. Please do not leave your dentures, hearing aids or eyeglasses on your food tray or under your pillow.

Jewelry, cash, and other valuables should be given to your friends or relatives to take home, or they may be checked at the Security Office; ask your nurse to prepare a valuables envelope. We are not responsible for lost cellphones, laptops or any other electronic devices.

The hospital requests that you use the belongings bags provided for the transportation of personal belongings.

Please note that the hospital cannot assume responsibility of any personal property that could be misplaced during your hospitalization.

## VISITING HOURS

Visiting hours for inpatients are 11 a.m. to 8 p.m. seven days a week. All visitors must sign in and use the visitor pass system. The hospital recognizes the rights of the patients to rest and recuperate, and, therefore, reserves the right to limit the number of visitors. Those under age 14 accompanied by an adult may visit Saturdays, Sundays and legal holidays from noon to 4 p.m. Visitation guidelines for special patient populations are as follows:

**Critical Care:** RWJ Rahway allows 24-hour visits for families in Critical Care. Please limit visitors to two (2) at a time, over the age of 13. We ask for no visits between 7 a.m. and 8 a.m., and 7 p.m. and 8 p.m. during our shift change.

**Care Connection (Skilled Nursing Facility):** Anyone in the family can visit anytime day or night. There are no restrictions.

*We have discounted weekly parking for \$10. See the cashier in the lobby to purchase a card.*

Under special arrangement, only one (1) visitor may stay at the patient's bedside overnight (inpatients only). Visitors who have colds, flu or who have signs/symptoms of infections are requested to refrain from visiting patients.

Visitors of patients in isolation are required to follow isolation protocol. Nursing staff may ask visitors to leave a patient area when circumstances indicate that it is in the best interest of the patient and/or visitor. Patient requests to refuse visitation are reasonably honored by hospital staff.

## TELEVISION AND PHONE SERVICE

Are activated automatically at a charge of \$8.50 per day. To opt out, call 2417. It is requested that you use personal ear phones when viewing television after 10 p.m.

Closed caption television is available.

Call ext. 6157 for TV repair.

## *ADVANCE DIRECTIVE*

**Guide to Living Will and Health Care Representative:** You have the right to make decisions about your healthcare. However, should you become severely incapacitated, either physically or mentally, you might be unable to make your own healthcare decisions. In such an event, those responsible for your care would try to make decisions based upon what they know of your wishes. An advance directive helps doctors and other caregivers provide the desired and most appropriate level of care for you.

Decisions about life-prolonging treatments are difficult and require careful consideration. Ideally, these decisions should be made before a time of crisis because full treatment is always carried out unless the healthcare team has been instructed otherwise. Your wishes are communicated to the healthcare team by means of an advance directive.

The Self-Determination Act, passed by Congress in 1991, is a law requiring healthcare facilities to ask patients whether they have executed an advance directive at the time of admission. The hospital is required to provide information about advance directives and healthcare decisions.

Advance directive, also called a living will, is recognized in New Jersey as a legal document that offers evidence of an individual's medical treatment preferences.

A patient can have an advance directive, a healthcare representative or a combination of both. This is an effective way of maintaining control over your care if you are incapacitated and unable to make decisions. It is the policy of RWJ Rahway to honor the advance directive. Advance directives can be found throughout the hospital.

her choosing for private professional nursing care during hospitalization.

In order to ensure that the standards of care at RWJ Rahway are met, all private duty RNs/LPNs contracted will adhere to the same policies and procedures as those followed by the Patient Services personnel.

At the time of their first shift at RWJ Rahway, all private duty RNs/LPNs must present the following:

- Current New Jersey License
- Current BCLS
- Medical Malpractice Insurance

In addition to providing the above, all private duty RNs/LPNs administering medications at RWJ Rahway must be able to provide proof of having successfully passed the RWJ Rahway NLN Pharmacology examination.

On request, RWJ Rahway will provide a list of those agencies that meet the hospital criteria. Please ask your nurse or nurse manager for the list of nursing agencies.

Questions can be addressed by calling 732-499-6059 weekdays between 9 a.m. and 5 p.m. On weekends and holidays, the clinical administrative coordinator on duty is responsible and can be reached by calling the telephone switchboard operator, 732-381-4200, who will refer the call appropriately.

## *TRANSPORTATION*

Taxi service can be secured for transportation home by asking your social worker or case manager.

### **Transport (patient):**

The Social Service Department will coordinate transportation for patients who require transfer to another facility or home.

Medicare will only pay for transportation when “medically necessary.” Medicare determines medical necessity, and its guidelines have become more restrictive. Medicare reimbursement cannot be guaranteed.

Transportation also is available by invalid coach. This transportation is less costly than an ambulance but is not reimbursable through Medicare.

The ambulance companies will bill your insurance

company if the contract covers transportation. If the claim is denied, the patient will be responsible for the cost of transportation.

If you have any questions, please contact the Social Service Department at 732-499-6151.

Transportation also is available by the Community Health Care Transportation Service. Our van will provide you with FREE service to RWJ Rahway for outpatient testing and treatment, weekdays from 7:30 a.m. to 3 p.m. To arrange for a ride, call 732-499-7779, or tell the operator you need a ride to your appointment. ## *BLOOD TRANSFUSIONS AND DONATION*

All blood transfused in New Jersey is collected from volunteer blood donors. Methods employed in New Jersey include rigorous screening and exclusion of donors who are at high risk of exposure to AIDS and hepatitis. Each unit of blood is tested by the latest FDA-approved method for the presence of the antibody to hepatitis and HIV viruses. These measures have proven to be very effective.

### *Autologous (Self) Blood Donation*

Autologous blood donation refers to the practice of donating one's own blood for storage prior to a medical or surgical procedure. Directed or designated blood storage refers to designating the blood of a specific individual for use by you during a medical or surgical procedure. For information regarding this service, contact the RWJ Blood Services at 732-235-8100 x 221 or 248.

### *Organ and Tissue Donors*

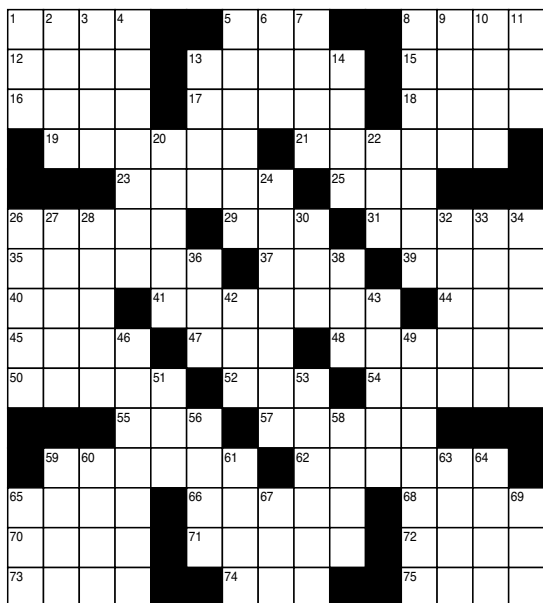
