MISSION STATEMENT

The goal of the program is to develop practitioners capable of serving as experts in medication safety, medication-use policy, formulary management, and drug/medical information practice. Our core mission is to provide the PGY2 MUSP resident with opportunities to:

- Participate in a broad range of medication management experiences with an emphasis in medication safety and medication-use policy including formulary management and implementation, drug shortage management, fostering a culture of safety, evaluating and reporting adverse drug reactions and medication errors, quality improvement, and provision of drug information.
- Develop skills in critical literature evaluation, evidence-based medicine, interdisciplinary committee coordination, pharmacy informatics, and clinical research.
- Enhance leadership and academic skills through co-precepting pharmacy students and delivering didactic education at the School of Pharmacy.

CURRICULUM

- Required Learning Experiences: Academia & Leadership, Corporate Pharmacy/Quality & Administration, Drug Information, Drug Shortages, Medication Safety, Operations/Staffing, Orientation (July), Pharmacy Informatics, Quality Improvement/Research

PROGRAM OVERVIEW

The PGY2 Medication-Use Safety and Policy Residency program offers advanced training that prepares the resident to assume a leadership role in devising and implementing system changes that improve the safety, efficiency, and appropriateness of the medication-use system and expertise in medication-use policy development and analysis of medication-related information. The resident will be involved in various medication use, safety and quality activities in conjunction with the Rutgers/RWJBarnabas Health Medication-Use Safety and Information Center (MUSIC). While the majority of rotations are completed at Robert Wood Johnson University Hospital, there are also opportunities for offsite rotations within government, non-profit, and pharmaceutical industry partners. The following outcomes will be achieved:

1. Demonstrate excellence in the provision of education, training, and evidence-based information to health care professionals, learners, and the public.
2. Participate in the management of the organization's formulary and medication-use policies.
3. Participate in the management of drug and supply shortages.
4. Analyze complex systems to identify and correct system flaws.
5. Design and complete a self-directed research project with a focusing on medication safety or medication-use management
6. Develop effective communication techniques and understand the way human factors that impact the safety of patient care.
7. Learn and apply methods to promote a culture of safety.
8. Participate in the application of technologies that improve the medication-use process.
9. Participate and lead committees promoting medication safety and formulary/therapeutic management.
10. Participate in the teaching of drug information and medication-use safety/policy focused content at the Ernest Mario School of Pharmacy - Rutgers, The State University of New Jersey.

QUALIFICATIONS

Applicants should hold a PharmD degree from an ACPE-accredited school/college of pharmacy, be a licensed pharmacist (or eligible for licensure) in New Jersey, and possess adept communication and interpersonal skills. Completion of an ASHP-accredited (or candidate status) PGY1 Pharmacy residency is required.

The position is available beginning on or around July 1, 2025 for a 12-month appointment.
