c. Applications Under Consideration

Climate Change and Food Allergy

The objectives of this proposal are to determine the impact of climate change on the allergenicity (allergen content) of various species of plants associated with food allergy (peanuts, soy, wheat) using plant chambers with in vitro (immunological, molecular plant genomics) assays. Presently assessing the content of peanut allergen content of peanuts grown at 2 different CO2 concentrations.

Sea Breeze and Impact on Human Health

The major goals of this project are to promote the Oceans and Human Health Initiative with a focus on Asthma, Allergies and Infectious agents impact by studying the impact of sea breeze and aerosolizations on the inflammatory responses on the respiratory track and the development on a educational curriculum for the general public.

Pollen Exposure Forecasting

The prevalence of allergic diseases has increased in the United States and other parts of the world during the last 30 years. Allergic diseases (e.g., rhinitis and asthma) are some of the top chronic diseases in the U.S. and cost approximately \$21 billion per year. One of the most significant contributors to this increase could be the exposure to aeroallergens such as ragweed (*Ambrosia* spp.) pollen. Anthropogenic land use and climate change may be contributing to the increased level of ragweed, and other native and invasive species pollen exposure. Expanding on the present EPA STAR grant usign Bayesian pollen modeling and the utility of NASA's time series of remotely sensed MODIS phenology data (in integration with current and future climatic predictors) in forecasting seasonal pollen production and predicting "hotspots" of risk of human exposure to seasonal allergies across the United States and show how changes in

phenology, land use, and climate can alter seasonal allergies and exposure to humans. The modeling will greatly advance spatial-temporal modeling capabilities, and the on-line mapped products will provide important information to public health managers to prioritize areas for prevention and control efforts for managing seasonal allergies under changing phenology, climate and land use. The online maps will be used by scientists, news services, doctors, and the public.
